IMPORT PRICE INDEX - September 2016 QUARTER (Base Period: March 2009 quarter = 100.0)

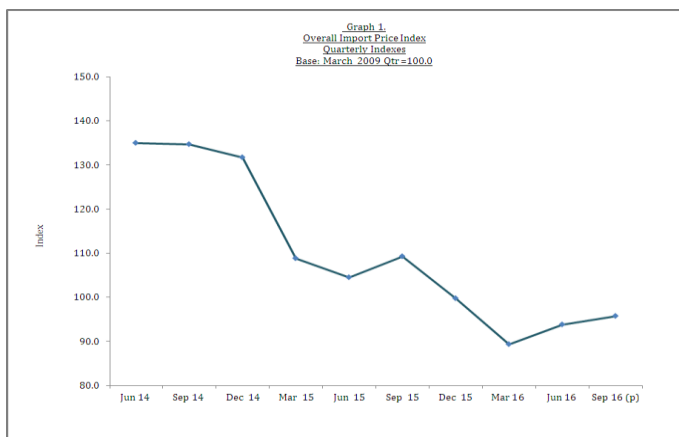
Highlights of the quarter

- Import price index rose 2.1 percent from the June 2016 quarter.
- Mineral Products index recorded the largest increase (up 4.3 percent).

Overview

The Import Price Index for the September 2016 quarter showed an overall increase of 2.1 percent from the June 2016 quarter. In comparison with the September 2015 quarter, the current import price index fell 12.4 percent.

The four quarters ending September 2016 decreased 16.6 percent in the overall import price index compared to the four quarters ending September 2015. See table 1 and graph 1.



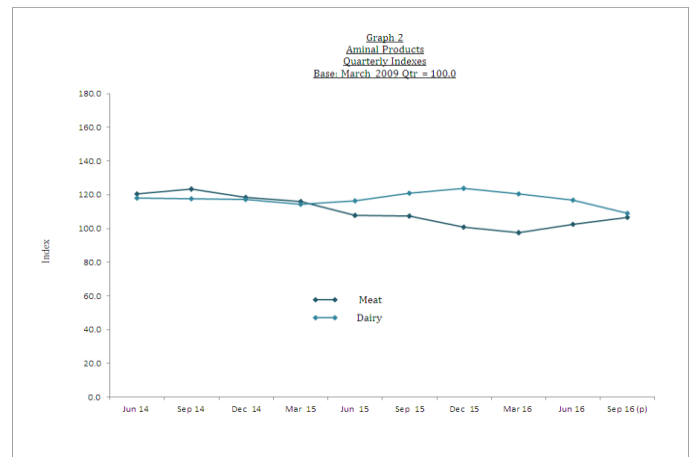

HS Section 1: Live Animals; Animal Products prices rise 0.4%.

Import prices for Live Animals and Animal Products in the September 2016 quarter rose 0.4 percent, following a 2.6 percent rise in the June 2016 quarter. The current increase was led by

higher prices of meat products, reflecting higher prices of sheep meats (up 5.2 percent) and poultry meats (up 2.3 percent). In comparison with the September 2015 quarter, the current live animals and animal products index decreased 3.7 percent.

The four quarters ending September 2016 showed a decrease of 6.5 percent in the overall live animals and animal products index over the four quarters ending September 2015. See tables 1 & 2 and graph 2.

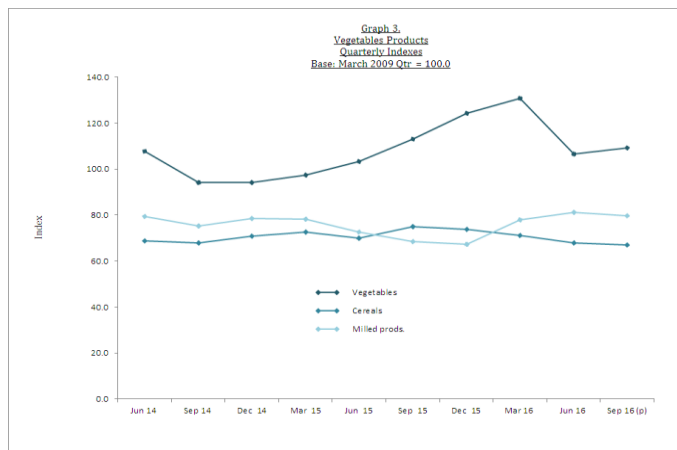

HS Section 2: Vegetable Products prices fall 0.6 %.

Import prices for Vegetable Products fell 0.6 percent in the September 2016 quarter, following a 4.1 percent fall in the June 2016 quarter. The current fall was influenced by lower prices of potatoes (down 19.5 percent), rice (down 1.1 (percent) and wheat (down 1.7 percent) and partly offset by higher prices of onions (up 33.7 percent). In comparison with the September 2015 quarter, the current vegetables products index increased 3.4 percent.

Reviewing the four quarters ending September 2016 over the four quarters ending September 2015, the current overall vegetable products index increased 4 percent. See tables 1 & 2 and graph 3.

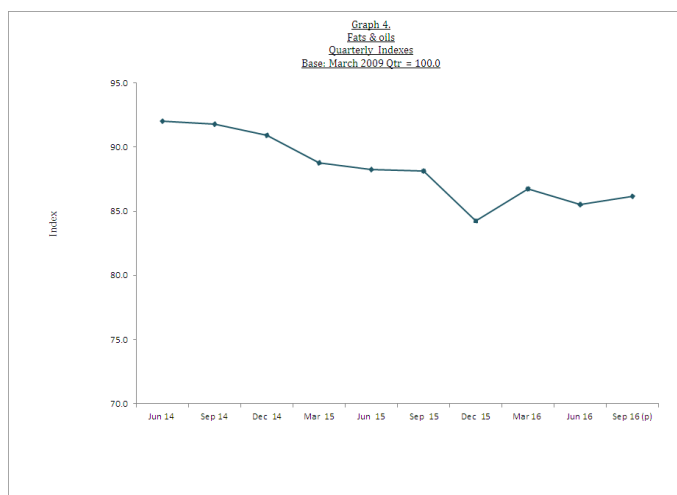

HS Section 3: Animal or Vegetable fats & oils prices rise 0.7%.

Animal or Vegetable fats and oils import prices rose 0.7 percent in the September 2016 quarter, following a 1.4 percent fall in the June 2016 quarter. The rise over the previous quarter was influenced by higher prices of margarine (up 1.9 percent). When compared with the September 2015 quarter, the current animal or vegetable fats oils index decreased 2.3 percent.

The four quarters ending September 2016 showed a decrease of 3.8 percent in the overall index for animal or vegetable fats and oils over the four quarters ending September 2015. See tables 1 & 2 and graph 4.

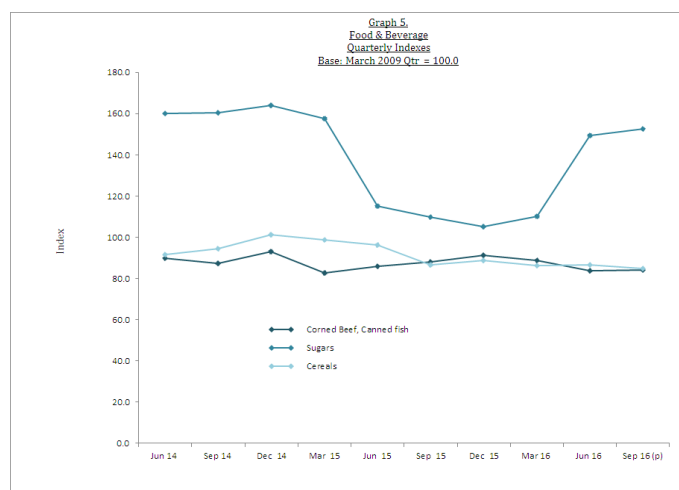

HS Section 4: Food and Beverages prices rise 0.3%.

Food and Beverages import price rose 0.3 percent in the September 2016 quarter, following a 7.9 percent increase in the June 2016 quarter. The rise was due to higher prices of sugar (up 2.1 percent) and corned beef (up 1.3 percent). In comparison with the September 2015 quarter, the current food and beverages index increased 8.4 percent.

When comparing the four quarters ending September 2016 with the four quarters ending September 2015, the overall food and beverages index decreased 4.8 percent. See tables 1 & 2 and graph 5.

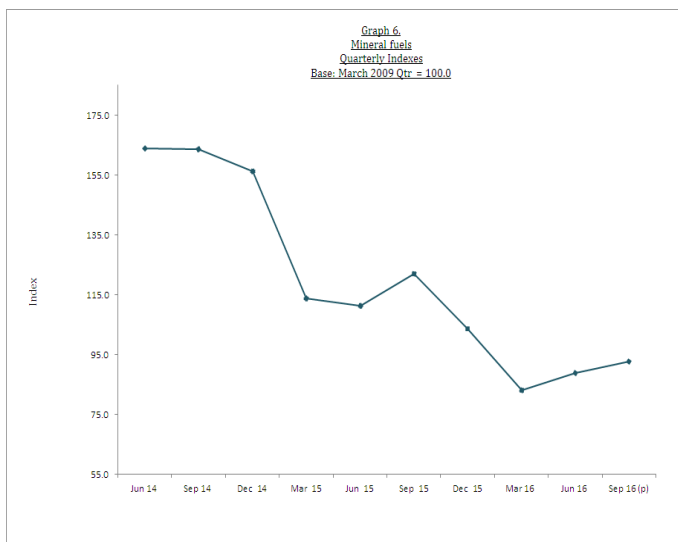

HS Section 5: Mineral Products price rose 4.3%.

Import prices for mineral products rose 4.3 percent in the September 2016 quarter, following the 6.8 percent rise in the June 2016 Quarter. In comparison with the September 2015 quarter, the current mineral products index decreased 24 percent.

The overall mineral products index in the four quarters ending September 2016 was 26.8 percent lower than the four quarters ending September 2015. See tables 1 & 2 and graph 6.

Technical Notes

The Import Price Index (MPI) measures changes in the cost, insurance, and freight (CIF) prices of imports of merchandise into Samoa. It is a fixed weight index with March 2009 quarter = 100.0 and is calculated on a quarterly basis using the International Harmonized System of Trade Classification (HS). The items included in the index were selected on the basis of their importance to the total import.

The scope of the MPI relates to the following sections of the International Harmonized System of Trade Classification (HS): 1. Live Animals: Animal Products, 2. Vegetable Products, 3. Animal or Vegetable fats and oils, 4. Food and Beverages and 5. Mineral Products, The index represents 50 percent of total Imports.


