### Merchandise Trade October 2017

#### Highlights of the month

#### Exports<sup>1</sup>

- ✚ Exports were valued at \$8.3 million, decreasing 19.6 percent from September 2017.
- ✚ Exports of 'Food and live animal' commodities recorded the largest decrease (down \$1.1 million) from September 2017 but remained the top commodity groups exported during October 2017, representing 49.0 percent of total exports value.
- ✚ Exports to New Zealand, Australia and American Samoa recorded largest decreases from September 2017.

#### Imports

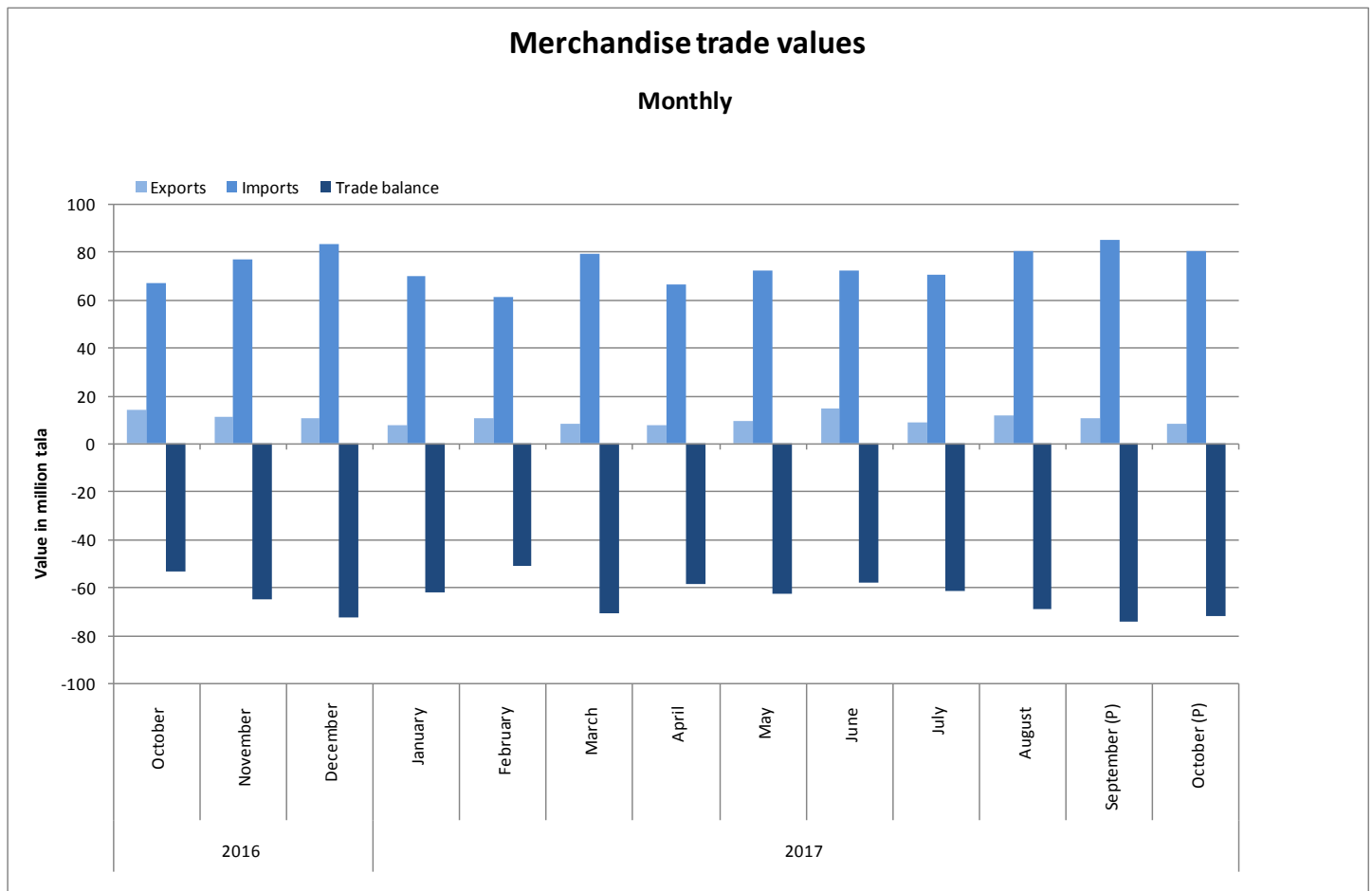
- ✚ Imports were valued at \$80.4 million, decreasing 5.2 percent from September 2017.
- ✚ The current decrease was mainly driven by lower values of 'Manufactured Goods', and 'Mineral fuel' imports
- ✚ 'Food and live animals' imports remained the top commodity groups imported during October 2017, representing 25.2 percent of total imports value.
- ✚ Imports from Hong Kong, Japan and Singapore recorded largest decreases from September 2017.

#### Trade Balance

- ✚ The value of imports (\$80.4 million) exceeded that of exports (\$8.4 million), resulting in a trade deficit of \$72 million.

#### **Technical Notes**

The main source of imports and exports data comes from the administrative document; a completed customs form (Single Administrative data-SAD) which is required to be filled in by importers and exporters or customs agents when clearing merchandise inward and outward through the Ministry for Revenue (Custom Department)

The November 2017 Merchandise trade report is expected to be available on January 22<sup>nd</sup> 2018.
