CONSUMER PRICE INDEX SEPTEMBER 2025

September 2025 compared to September 2024:

- The Consumer Price Index increased by 2.8%.
- ❖ The most significant price increases were:
- ✓ Food and Non-Alcoholic beverages (1.8%)
- ✓ Alcoholic Beverages. **Tobacco & Narcotics** (0.6%)
- * The CPI fell by 0.5% from August 2025
- The Average Annual Inflation was 2.8%

SUMMARY

The Consumer Price Index (CPI) for September 2025 rose by 2.8 percent compared with September 2024, but declined by 0.5 percent compared to August 2025.

The main contributors to the increase were Food and non-alcoholic beverages and Alcoholic beverages, tobacco & narcotics, driven by higher prices for chicken leg quarters, corned beef, cooking oil, Pall Mall cigarettes, and paper cigarettes.

The **Imported** goods component increased by 2.3 percent over the year, reflecting higher prices for food items, Pall Mall cigarettes, televisions, household cleaning products, Nike running shoes, and exercise books.

The **Local** goods component increased by 3.3 percent, mainly due to higher prices for Chinese cabbage, CCK coffee, round cabbage, and coconuts.

Graph 1 shows the percentage changes in the CPI over the same month of the previous year across all divisions from September 2024 to September 2025.



All Divisions' Contribution to CPI

In September 2025, Food & Non-alcoholic beverages was the largest contributor to the 2.8 percent rise in the CPI, accounting for percentage points of the overall increase. Higher prices for chicken leg quarters (up 12.3%), corned beef (up 23.9%), cooking oil (up 13.6%), Chinese cabbage (up 34.5%), CCK coffee (up 22.4%), coconut (up 17.0%), and round cabbage (up 12.3%) were the primary drivers.

The Alcoholic beverages, tobacco and narcotics division was the second largest contributor, accounting for 0.6 percentage points of the overall increase, primarily due to higher prices for Pall Mall cigarettes (up 9.0%), paper cigarettes (up 5.7%), and Samoan kava (up 5.3%).


Restaurants contributed 0.2 percentage points to the CPI increase, mainly due to significant price rises in fish & chips (up 10.6%) and steamed rice with chicken meal (up 21.4%).

Transport, and Miscellaneous goods and services each accounted for 0.1 percentage points of the CPI increase, driven by higher prices for return tickets to Pago Pago (up 18.7%), return tickets to Auckland (up 17.7%), private car registration (up 25.0%) and toiletries (up 12.5%).

Clothing & Footwear, Housing, Water, Electricity, Gas & other fuels, Health and Communication each contributed less than 0.1 percentage points to the CPI increase. The main drivers were higher prices for Nike running shoes (up 14.5%), liquid gas (up 5.1%), amoxicillin 500 mg tablets (up 3.2%) and mobile phone calling rates for local calls (up 160.0%)

In contrast. Recreation & Culture and Furnishing, household equipment maintenance divisions recorded negative contributions to the CPI, driven by lower prices for laptops (down 24.3%) and washing powder (down 8.0%).

Graph 2 shows the percentage contribution of All Divisions to the CPI in September 2025.




Consumer Price Index (% Change)

The largest month-on-month increase in the CPI was recorded in Restaurants and Hotels, which rose by 9.0%, followed by Alcoholic Beverages, Tobacco and Narcotics (up 4.6%). Food and Non-Alcoholic Beverages increased by 3.8%, while Health rose by 3.4%. Miscellaneous Goods and Services increased by 1.9%, and Clothing and Footwear by 1.6%. Housing, Water, Electricity, Gas and Other Fuels, as well as Communication, both recorded a 0.2% rise. Other divisions such as Transport and Education increased by 0.6% and 0.1% respectively.

On the other hand, Recreation & Culture and Furnishings, household equipment & maintenance fell by 1.5% and 1.0% respectively.

Graph 3 shows the percentage change for all Divisions (Groups) in September 2025 compared to September 2024.



Changes by Division / Group

Restaurants & Hotel Index

The Restaurants & hotel index rose by 9.0%, driven by higher prices for fish & chips meals (up 10.5%), chicken and chips meals (up 4.2%), and steamed rice with chicken meals (up 21.4%).

Alcoholic Beverages, Tobacco and Narcotics Index

The Alcoholic Beverages, Tobacco, and Narcotics index increased by 4.6% compared to September 2024, primarily due to a rise in Pall Mall cigarette prices (up 9.0%) and paper cigarettes (up 5.7%).

Food and Non-Alcoholic Beverages Index

The Food & Non-Alcoholic Beverages index rose by 3.8%, driven by higher prices for several items, including chicken leg quarters (up 12.3%), corned beef (up 23.9%), cooking oil (up 13.6%), Chinese cabbage (up 34.5%), coffee (up 22.4%), coconut (up 17.0%) and round cabbage (up 12.3%).

Miscellaneous Goods and Services Index

The Miscellaneous Goods and Services index increased by 1.9%, mainly due to higher prices for toiletry supplies (up 12.5%).

Clothing and Footwear Index

The Clothing and Footwear index increased by 1.6%, largely due to higher prices for le Solosolo (up 9.0%) and Nike running shoes (up 14.5%).

Health Index

The Health index increased by 3.4% mainly due to the rise in amoxicillin tablets (up 3.2%).

Transport Index

The Transport index rose by 0.6% due to increases in the prices of return tickets to Pagopago (up 18.7%), return tickets to Auckland (up 17.7%) and car registration (up 25.0%).

Housing, Water, Electricity, Gas & other Fuels and Communication Indices

The Housing, Water, Electricity, Gas & other fuels and Communication indices both increased by 0.2% due to a rise in liquid gas prices (up 5.1%), mobile phone calling rates for local calls (up 160.0%) and calls to New Zealand (up 12.7%).


Education Index

The Education index increased by 0.1% due to an increase in Primary registration fees (up 0.3%).

Furnishings, Household Equipment & Maintenance and Recreation & Culture Indices

Furnishings, Household Equipment & Maintenance and Recreation and Culture indices decreased by 1.0% and 1.5%, respectively. This was due to decreases in the prices of washing powder, refrigerators and laptops.







Underlying Indices


The All Items Underlying Index increased by 3.4% in September 2025 compared to September 2024 but declined by 0.1% compared to August 2025.

The Imported Items Underlying Index rose by 3.8%, while the Local Items Underlying Index increased by 2.5%.

Annual Inflation Rate

The average annual inflation rate for the year ending September 2025 was 2.8%. In contrast, the inflation rate for the twelve months ending September 2024 was 2.9%.

Graph 4 presents the average annual inflation rates from September 2024 to September 2025.

Technical Notes:

The Consumer Price Index (CPI) measures the rate of inflation for Samoa. It tracks the change in prices of goods purchased by households in Samoa by comparing the prices of a basket of goods and services during the collection period with the prices of the same items in a base period.

The basket of goods used for pricing is based on the average expenditures of households as recorded in the Household Income and Expenditure Survey (HIES). This survey identifies the typical spending patterns of households. Items that households spend more on, on average, are given greater weight in the CPI index.

1/ Monthly movements in the 'headline' CPI can be volatile. This volatility reflects price changes in specific items, which may be influenced by factors such as fluctuations in commodity markets, agricultural conditions. policy changes, or seasonal adjustments and infrequent price resets.

Underlying inflation is a measure of inflation that excludes certain items with volatile price movements. It eliminates products that experience temporary price shocks, as these shocks can distort the overall inflation trend and provide an inaccurate measure of long-term inflation.




