
1. TOTAL ARRIVALS

The total International Arrival Statistics recorded for the month of <u>April 2024</u> totaling 18,295 arrivals, revealed an increase of 12.5 percent over the previous month of March 2024 and a decrease of 4.5 percent over the corresponding month of April 2023.

Those who travelled to Samoa by Air represented 92.3% while 7.7% was represented by those who travelled by Sea.

Fig. 1 below graphically depicts the arrival numbers from April 2015 to April 2024, clearly showing the impact of Covid 19 on arrival numbers for April in 2021 and 2022.

Fig. 1: April Total Arrivals, 2015 - 2024




2. TOTAL VISITORS

Overall visitor numbers for the month under review stood at 12,644 revealing an increase of 12.5 percent over the previous month of March 2024 and a decrease of 7.8 percent over the corresponding month of April 2023.

Fig. 2 illustrates the total number of visitors for April between 2015 and 2024, also indicating the impact of Covid 19 on visitor numbers for April in 2021 and 2022.

Fig. 2: April Total Visitors, 2015 - 2024




3. TOTAL ARRIVALS BY PURPOSE OF ENTRY

Visitors, (Table 2), made up the largest component of all arrivals with 61.7 percent (11,297), represented by 31.1 percent males (5,685) and 30.7 percent females (5,612).

Male returning residents made up 18.1 percent (3,316) of total arrivals while their female counterpart made up 12.8 percent (2,335). (Refer Fig. 3)

Fig. 3: Total Arrivals, by Purpose of Entry, April 2024




4. TOTAL VISITORS BY COUNTRY OF USUAL RESIDENCE

New Zealand remains as the leading country in visitors' arrival by country of usual residence (Table 3) accounting for 41.9 percent of total visitors or 5,303 visitors. Australia followed next with a distant 25.4 percent share (3,214).

United States of America reported 8.4 percent (1,062 visitors) while American Samoa reported 6.9 percent (868) of total visitors. (Refer Fig. 4)

Fig. 4: Total Visitors, by Country of Usual Residence, April 2024




5. TOTAL VISITORS BY REGION

As usual, the Oceanic Region had the highest share of total visitors with 80.2 percent, followed by America with 8.7 percent.

Asia reported a share of 7.6 percent while Europe reported the least share of 2.8 percent. (Refer Fig. 5).

Fig. 5: Total Visitors by Region, April 2024




6. TOTAL VISITORS BY PURPOSE OF VISIT

The principal source markets (Table 4) namely New Zealand, Australia, American Samoa and the United States of America constitute 82.6 percent of all visitors visiting Samoa in April 2024.

The majority of visitors (4,863) entered our shores for holiday and vacation while 4,150 entered our shores to visit friends and relatives.

Those who were here on Business/Conference recorded 696 visitors while those for Sports purposes reported only 160 visitors. Fig.6 depicts total visitors by purpose of visit for April 2023 and April 2024.

Fig. 6: Total Visitors, by Purpose of Visit, April 2023 & April 2024




7. TOTAL ARRIVALS BY CARRIER

As depicted in table 5, Air New Zealand carried the highest share of passengers to Samoa with 40.0 percent, (7,321 passengers) followed by Fiji Airways with 23.1 percent (4,230 passengers).


Fig. 7: Total Arrivals by Carrier, April 2024

Samoa Airways brought in 9.9 percent (1,815 passengers) of total arrivals while Quantas and Talofa Airways recorded shares of 8.4 percent (1,543) and 5.6 percent (1,024) respectively. Fig. 7 illustrates total arrivals by carrier during the reference period.

8. TOTAL VISITORS BY DURATION OF STAY AND PLACE OF STAY

As shown in Fig. 8 below, visitor's duration of stay in Samoa (Table 6) is between seven and thirty days.

On the other hand, the majority of visitors (55.5 percent or 6,669 visitors) reported staying in private accommodations or with families/ relatives while 39.9 percent (4,804) stayed in hotel/motel. (Refer Fig. 9).

Fig. 9: Total Visitors by Place of Stay, April 2024





Fig. 10 portrays the number of visitors who stayed in hotels/motels (4,804) by type of accommodation (hotel/ motel), within the reference month.

The sourced documents for the compilation of International Arrival Statistics are the immigration arrival and departure card forms.


These forms are completed by all incoming and outgoing travelers at the two local points of entry namely:

- (1) Faleolo International Airport
- (2) Apia Wharf (Matautu Port)
- (3) Fagalii International Airport

Futhermore, the BMS (Border Management Sytem) was also used for the compilation of such statistics.


International Arrival Statistics are compiled on a monthly, quarterly and annual basis. These reports can also be downloaded from our website: www.sbs.gov.ws

Graph 1: Monthly Total Arrivals, April 2019 - April 2024




