INTERNATIONAL ARRIVAL STATISTICS APRIL 2026

MONTHLY HIGHLIGHTS:

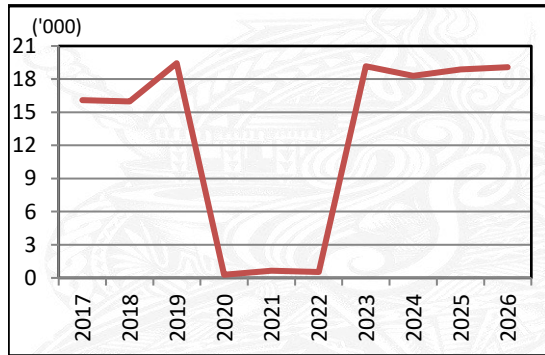
1. TOTAL ARRIVALS

The total International Arrival Statistics recorded for the month of **April 2026** totaling 19,086 arrivals, revealed an increase of 9.1 percent over the previous month of March 2026 and an increase of 1.2 percent over the corresponding month of April 2025.

Those who travelled to Samoa by Air represented 92.6% while 7.4% was represented by those who travelled by Sea.

Fig. 1 below graphically depicts the arrival numbers from April 2017 to April 2026, clearly showing the impact of Covid 19 on arrival numbers for April in 2020, 2021 and 2022.

Fig. 1: April Total Arrivals, 2017 – 2026

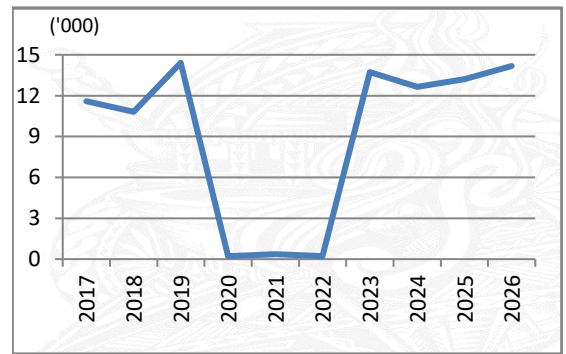


2. TOTAL VISITORS

Overall visitor numbers for the month under review stood at 14,188 revealing an increase of 13.2 percent over the previous month of March 2026 and an increase of 7.4 percent over the corresponding month of April 2025.

Fig. 2 illustrates the total number of visitors for April between 2017 and 2026, also indicating the impact of Covid 19 on visitor's numbers for April in 2020, 2021 and 2022.

Fig. 2: April Total Visitors, 2017 – 2026



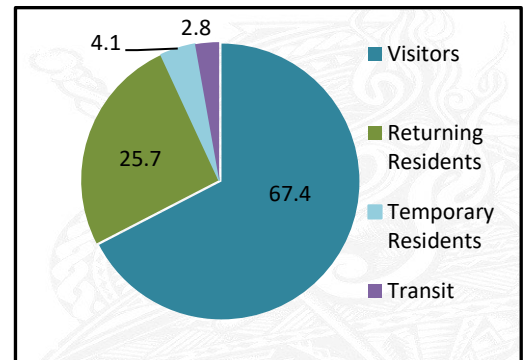
3. TOTAL ARRIVALS BY PURPOSE OF ENTRY

Visitors (Table 2), made up the largest component of all arrivals with 67.4 percent (12,867), represented by 34.9 percent females (6,662) and 32.5 percent males (6,205).

Male returning residents made up 14.9 percent (2,841) of total arrivals while their female counterpart made up 10.8 percent (2,057). (Refer Fig. 3)

Fig. 3: Total Arrivals, by Purpose of Entry, April 2026

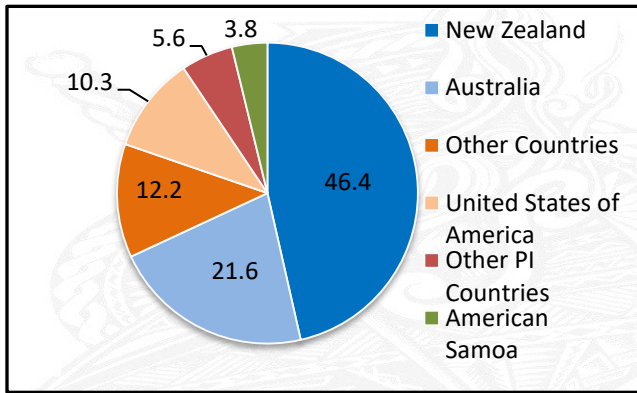


4. TOTAL VISITORS BY COUNTRY OF USUAL RESIDENCE

New Zealand remains as the leading country in visitors' arrival by country of usual residence (Table 3) accounting for 46.4 percent of total visitors or 6,585 visitors. Australia followed next with a distant 21.6 percent share (3,070).

United States of America reported 10.3 percent (1,456 visitors) while American Samoa reported 3.8 percent (542) of total visitors. (Refer Fig. 4)

Fig. 4: Total Visitors, by Country of Usual Residence, April 2026

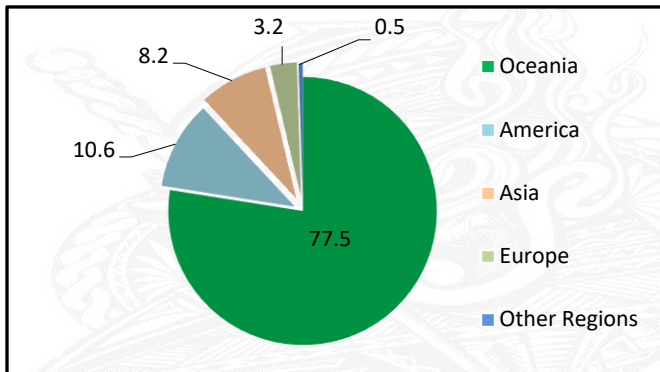


5. TOTAL VISITORS BY REGION

As usual, the Oceanic Region had the highest share of total visitors with 77.5 percent, followed by America with 10.6 percent.

Asia reported a share of 8.2 percent while Europe reported the least share of 3.2 percent. (Refer Fig. 5).

Fig. 5: Total Visitors by Region, April 2026



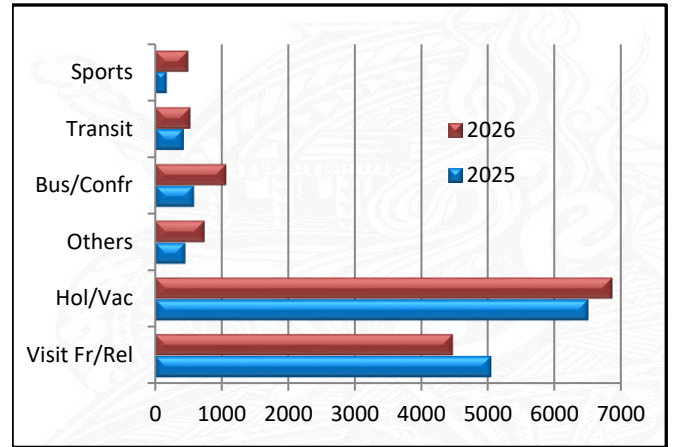
6. TOTAL VISITORS BY PURPOSE OF VISIT

The principal source markets (Table 4) namely New Zealand, Australia, American Samoa and the United States of America constitute 82.1 percent of all visitors visiting Samoa in April 2026.

The majority of visitors (6,865) entered our shores for holiday and vacation while 4,477 entered our shores to visit friends and relatives.

Those who were here on Business/Conference recorded 1,070 visitors, while those for Sports purposes reported only 498 visitors. Fig.6 depicts total visitors by purpose of visit for April 2025 and April 2026.

Fig. 6: Total Visitors, by Purpose of Visit, April 2025 & April 2026.

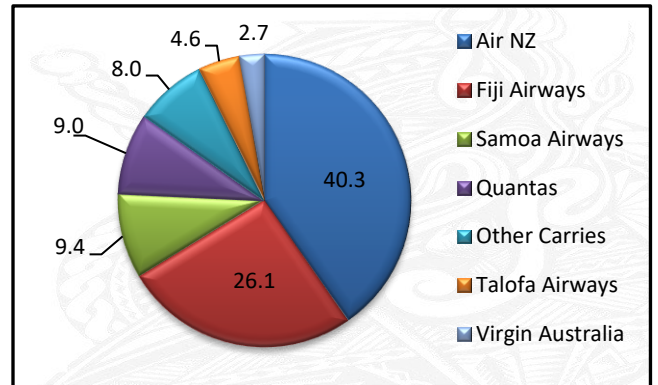


7. TOTAL ARRIVALS BY CARRIER

As depicted in table 5, Air New Zealand carried the highest share of passengers to Samoa with a 40.3 percent share, (7,693 passengers) followed by Fiji Airways with a 26.1 percent share (4,978 passengers).

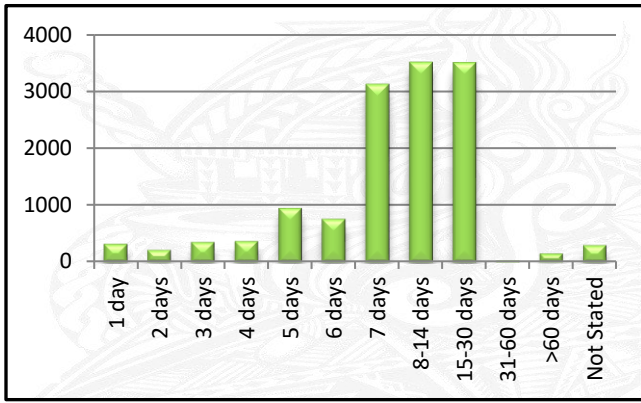
Fig. 7: Total Arrivals by Carrier, April 2026

Samoa Airways brought in 9.4 percent (1,787 passengers) of total arrivals while Quantas and Talofa Airways recorded shares of 9.0 percent (1,722) and 4.6 percent (870) respectively. Fig. 7 illustrates total arrivals by carrier during the reference period.

8. TOTAL VISITORS BY DURATION OF STAY AND PLACE OF STAY

As shown in Fig. 8 below, visitor's duration of stay in Samoa (Table 6) is between seven and thirty days.

On the other hand, the majority of visitors (54.4 percent or 7,433 visitors) reported staying in private accommodations or with families/ relatives while 39.3 percent (5,370) stayed in hotel/ motel. (Refer Fig. 9).

Fig. 9: Total Visitors by Place of Stay, April 2026

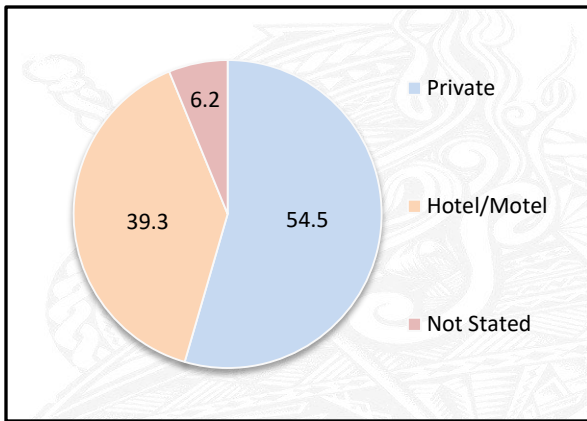
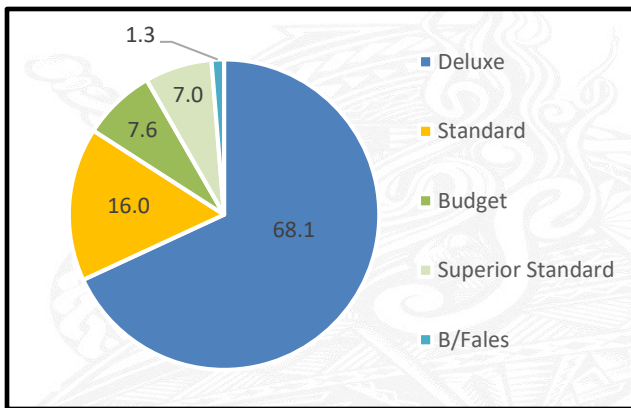


Fig. 10 portrays the number of visitors who stayed in hotel/ motel (5,370) by type of accommodation (hotel/ motel), within the reference month.

- (2) Apia Wharf (Matautu Port)
- (3) Fagalii International Airport

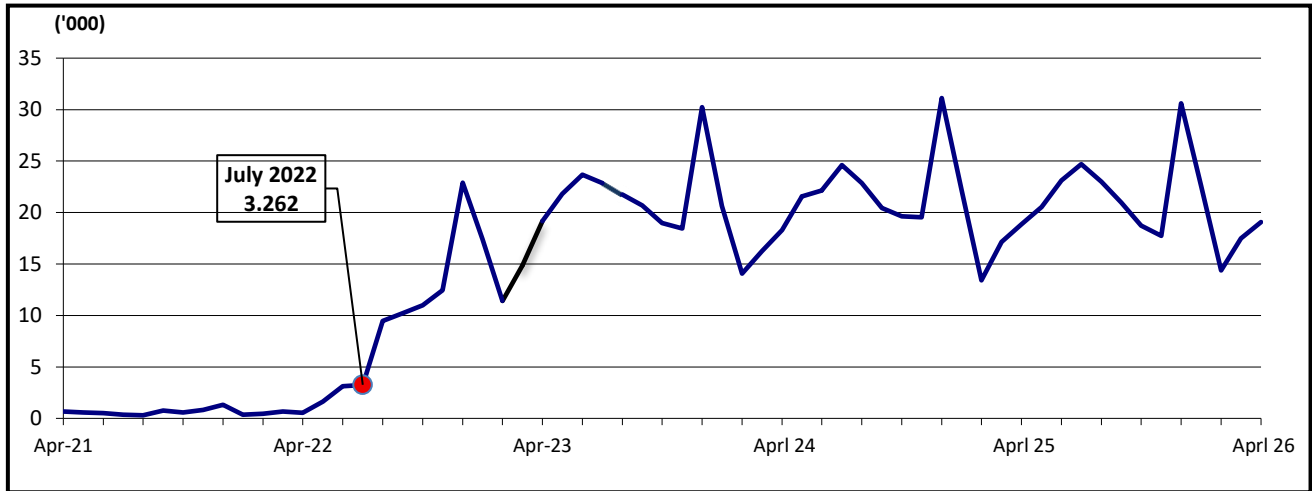
Futhermore, the BMS (Border Management Sytem) was also used for the compilation of such statistics.

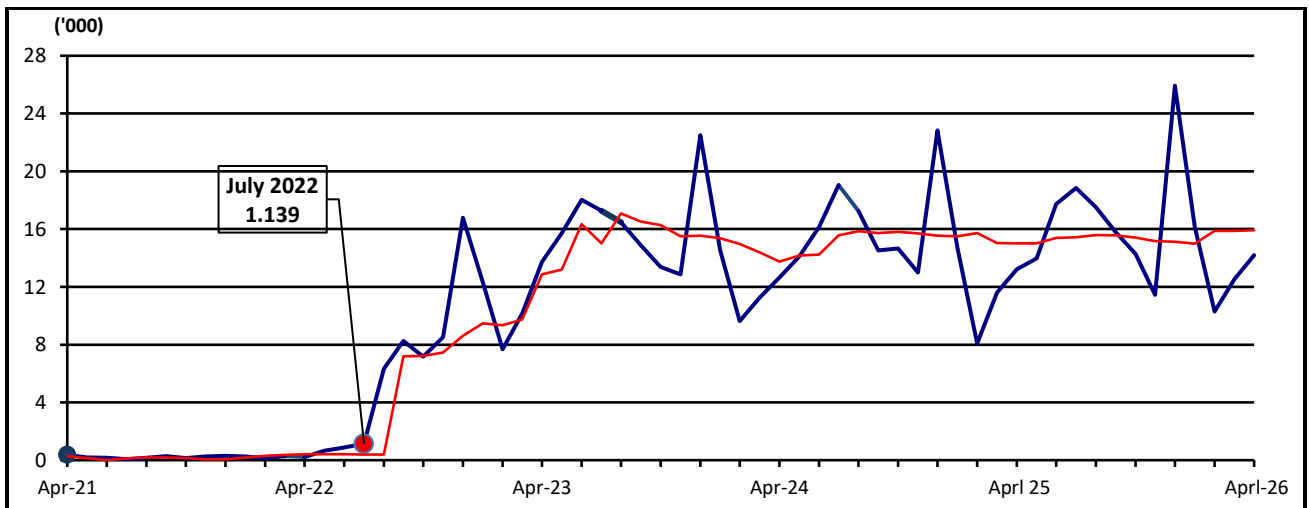

Graph 1: Monthly Total Arrivals, April 2021 – April 2026



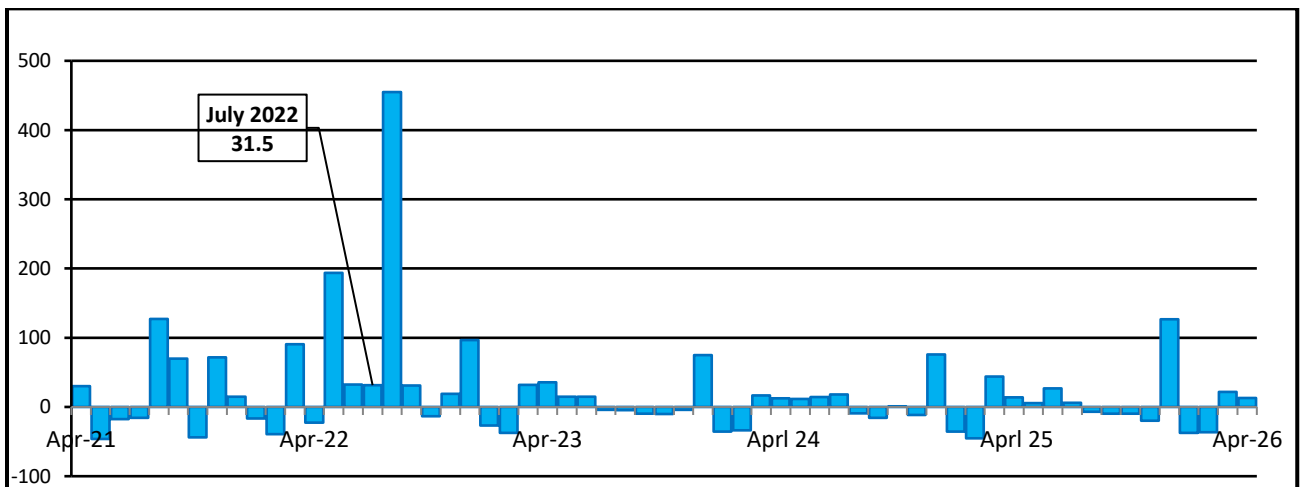
