### Overseas Merchandise Trade January 2021

#### **Highlights of the month**

*January 2021 compared with December 2020*

#### **Merchandise Exports<sup>1</sup>**

- ❖ The total value of merchandise exports declined 44.4 percent (or \$3.34 million) to \$4.18 million in January 2021. By main commodities, the monthly decrease was due to reduction of:
  - ✓ Fish, crustaceans and molluscs' (down \$0.17 million)
  - ✓ Minerals fuels, mineral oils and products (down \$0.19 million)
  - ✓ Beverages, spirits and vinegar (down \$0.12 million)
  - ✓ Vegetables products (down \$0.59 million)
- ❖ Exports to New Zealand (down \$0.4 million) and Tokelau (down \$0.15 million) recorded largest decreases in January 2021 reflecting reductions of coconut oil, taro and taamu exports to mention a few as well as nil exports to China due to the limitation of shipment for the reviewed month.
- ❖ American Samoa continued as the leading export market in January 2021, accounting for 38.9 percent of total merchandise exports value.

#### **Merchandise Imports**

- ❖ The total value of merchandise imports decreased 15.7 percent to \$71.52 million.
- ❖ This fall was mainly led by:
  - ✓ Meat and edible meat offal (down \$0.37 million)
  - ✓ Mechanical machinery and equipment (down \$6.50 million)
  - ✓ Iron and Steel (down \$0.21 million)
  - ✓ Electrical machinery and equipment (down \$1.25 million).
- ❖ Asia region recorded the largest decrease (down \$5.21 million) with Singapore the main driver of the current fall (down \$2.39 million) reflecting the reduction of petroleum imports in January 2021.


#### **Trade Balance**

- The total value of merchandise imports (\$71.52 million) was greater than that of total merchandise exports (\$4.182 million), resulting a trade deficit of \$67.34 million.
